## Professional Support Coordinator to Tasmania

### Fee Structure

#### Rationale

The Professional Support Fee Structure will apply to all eligible child care services (Australian Government Approved Child Care Services). Specific fees apply to non-eligible services.

The Professional Support Fee Structure will cover all services provided by PSCTas and its Professional Support Service Providers (PSSPs) engaged by PSCTas.

The Fee Structure will be based on national fee setting principles.

**All fees are GST inclusive.**

#### Scheduled Training Events

Eligible services: **\$10.00 per hour** per participant to a maximum of **\$60.00 per session**

Non-eligible services: **\$20.00 per hour** per participant to a maximum of **up to \$120.00 per session**.

#### Customised Training

Eligible services: **\$165.00 fixed fee for up to 3 hours**. This rate is for groups up to a maximum of 20 participants. Where numbers exceed 20, a fee of \$15.00 per additional participant will apply. Customised Training beyond a 3 hour session is at the rate of \$55.00 per hour for each additional hour.

Non-eligible services: **\$330.00 fixed fee up to 3 hours**.

#### \*Fees for customised training

PSCTas will invoice the service on advice from the training provider that training has been confirmed. Please note that in the event of cancellation (not postponement or rescheduling) requested by the service, a cancellation fee *equivalent to 50% of the total fee* will be charged and is non-refundable.

#### Consultations

This comprises an initial consultation to identify support needs and develop a plan of action, plus ongoing support as required.

Eligible services: **\$55.00 for up to 2 hours** for initial consultation; **\$15.00 per hour** for ongoing support.

Non-eligible services: **\$55.00 per hour** for initial consultation; **\$20.00 per hour** for ongoing support.

### QA Support

Ongoing telephone support is available through NCAC - **1300 136 554**

Initial PSC support by telephone or email: **up to 5 hours free of charge**

Initial on-site consultation: **\$55.00 for up to 2 hours** to identify needs and develop action plan. Ongoing consultation: **\$15.00 per hour**

### Specialist Equipment

Access to the pool of Specialist Equipment maintained by PSCtAs will be through regional Inclusion Support Agencies and will form part of Inclusion Support Subsidy (ISS) processes. **There is no charge for use of this equipment by eligible services.**

### Bicultural Support

Access to bicultural support services will be provided to AGACCS free-of-charge. Support from a bilingual worker is available for up to four hours per week to a maximum of ten weeks.

### Non-eligible Services

Non-eligible services can access general resources and training on a fee-for-service basis. AGACCS will have first priority to PSCtAs services at all times.

PSCtAs reserves the right to review the Professional Support Fee Structure at any time.

PSCtAs will give at least 4 weeks' notice of any impending change to existing fees.
